## 5. PROJECT UPDATES

### Wayfinding Signage

• Draft Strategy was distributed prior to the meeting.

- General discussion regarding the document with the following notes.
  - It was noted that the Entrance statement signs excluded from the scope of this project.
  - Artistic silhouettes on top of walking trails possible vandalism risk but unlikely if substantial thickness. Silhouette changes - Frog - Jum Rum Walk, Freshwater Croc + turtle - River Walk.
  - Hans Pehl signage opportunity to retain and repurpose as artwork in different locations, council will reinstall Hans Pehl signs prior to commencing new signs, repurpose to direct to international cities.
  - Signage has been developed to cost-effectively allow plates to be replaced as attractions close/change.
  - Maps on signs need north point (compass point).
  - Opportunity for signage in the pods not in this scope but to be developed in future (similar to entrance statement).
  - Symbols train use older trail silhouette and use words 'scenic rail' or similar
  - 'Theatre' directional signage no longer needed.
- The Committee agreed it was happy for Council to progress to next stage, which is final design, documentation preparation and calling for tenders.

#### **Barron Falls Walk**

- Council has been working with QPWS, WTMA and Traditional Owners to finalise approvals and design.
- Design to be finalised mid-August and tenders to be invited shortly after.
- Some private unapproved structures encroach on proposed path alignments, Council will be working with property owners to arrange for them to be removed. Council will also work with screen for those who wish to retain privacy.
- Design based on asphalt pathways, plus some bridges and stairs.
