EXECUTIVE SUMMARY

Council Officers have been in negotiation with Kilcor Properties Pty Ltd and the Department of Resources for some time in regard to the relinquishment of Trusteeship of the northern triangle portion of Lot 20 NR7137. In order to proceed further in negotiations efficiently, it is proposed that the Chief Executive Officer is provided delegation to finalise the negotiations. The delegation will not be executed until consultation with Councillors has been completed.

RECOMMENDATION

That Council delegates the Chief Executive Officer after consultation with Councillors:

- 1. to negotiate with Kilcor Properties Pty Ltd or associated entities to relinquish its Trusteeship of the northern triangle portion of Lot 20 NR7137, and
- 2. to make a statement in relation to an application by Kilcor Properties Pty Ltd or associated entities to the Department of Resources for purchase of the northern triangle portion of Lot 20 NR7137.

BACKGROUND

Council Officers have been in negotiation with Kilcor Properties Pty Ltd and the Department of Resources for some time in regard to the relinquishment of Trusteeship of the northern triangle portion of Lot 20 NR7137; refer to the attached map. In order to proceed further in negotiations efficiently, it is proposed that the Chief Executive Officer is provided delegation to finalise the negotiations. Part of the process is for Council to complete a 'Statement in relation to an application under the Land Act 1994 over State land'. This application is providing in principle support for Kilcor Properties Pty Ltd to negotiate with State to purchase State-owned land, which Council currently holds Trusteeship. The delegation will not be executed until consultation with Councillors has been completed.
