Please find attached a development application for the boundary realignment of Lot 487 on HG630 and Lot 50 on SP227044.



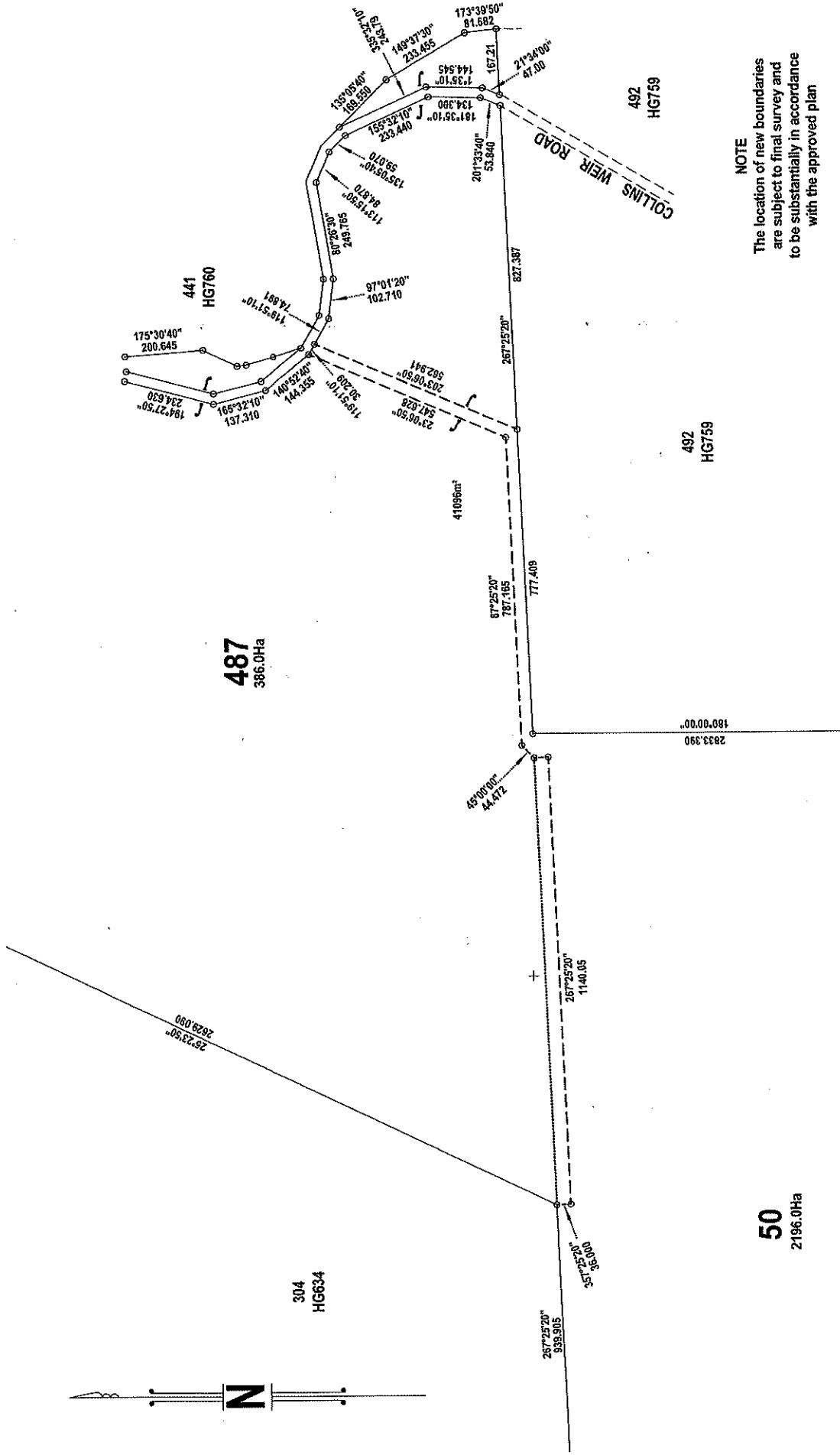
