**AMBULATORY BOUNDARY REPORT**

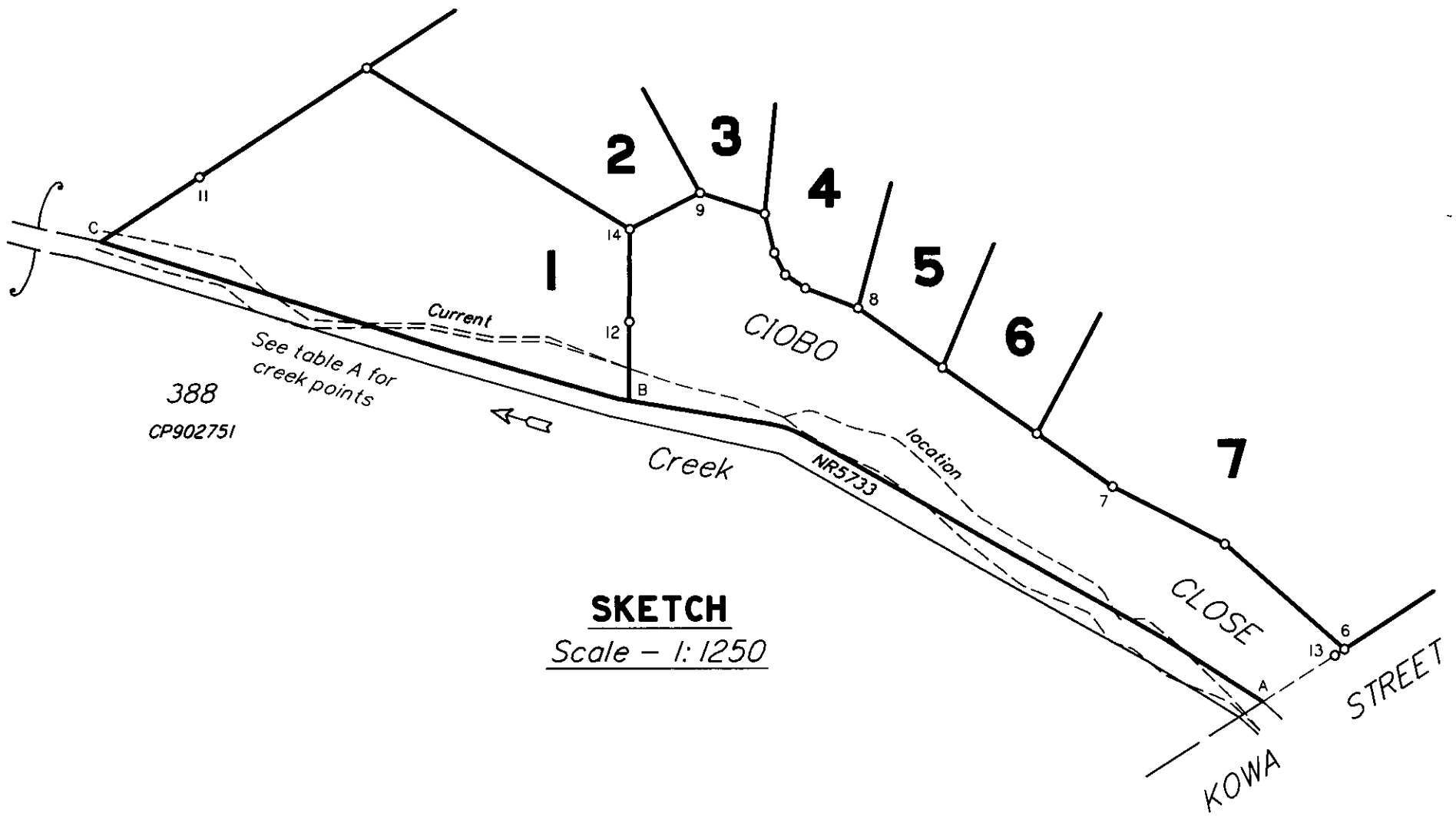
The land was previously surveyed on NR5733 in 1972 and the top of bank was adopted to define the boundary.

The boundary is in accordance with its location on an application of the ambulatory principles to the natural feature.

The following evidence has been collected during field inspection and field survey, indicating that the ambulatory boundary has been subjected to sudden change. The sketch below displays the original and current location of the feature. We believe that the feature has been affected due to earthworks such as filling to create extra hardstand area for Lot 388 on CP902751 (council depot).

The best evidence is that the natural feature was located as depicted on NR5733.

The current location of the original adopted natural feature has been determined by field notes submitted with NR5733 and has been confirmed by field survey where station A compares within reason as that area could possibly have been affected due to roadwork construction.
