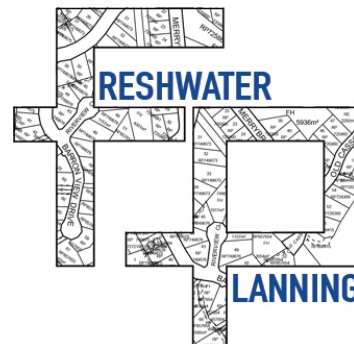

**RE: APPLICATION FOR RECONFIGURING A LOT – 1 LOT INTO 2 STANDARD FORMAT LOTS AND COMMON PROPERTY [STANDARD FORMAT PLAN].
LOT 74 ON SP325396, 1 MATILDA CLOSE AND 27 SUMMER STREET, MAREEBA.**

This application is for a Reconfiguring a Lot – 1 Lot into 2 Standard Format Lots and Common Property over land described as Lot 74 on SP325396, situated at 1 Matilda Close and 27 Summer Street, Mareeba is submitted on behalf of D. Pianeda and M.D. Comerford the owners of the site.

The application comprises of Application Form, SmartMap, Sketch Plan and this Town Planning Submission. It is understood that the proponent will provide payment of the Application Fee.

The Site

The subject land is described as Lot 74 on SP325396, Locality of Mareeba and situated at 1 Matilda Close and 27 Summer Street, Mareeba. The site is owned by DANE PIANEDA, MEGAN DEBORAH COMERFORD who are also the applicants for the proposed Reconfiguration. The site is generally regular in shape, has an area of 1,032 m², contains frontage to Matilda Close and Summer Street and encompasses two existing Dwelling Units. The Dwelling Units comprise of two (2) x three Bedroom two Bathroom Units with covered garages.

The site is access from the existing Road Network, being Matilda Close and Summer Street. The site is provided with all available and necessary services, being power, water, sewerage, and telecommunications (Urban Servicing).

In relation to the current State Governmental Mapping the site is Not Mapped as containing Remnant Vegetation, Regrowth Vegetation and Essential Habitat nor is the site designated as including a Referable Wetland or Wetland Protection Area. The site is not located within 25 metres of a State Controlled Road or a Railway Corridor. It is considered that the proposal does not require Referral to any State Agencies.

The Proposed Development

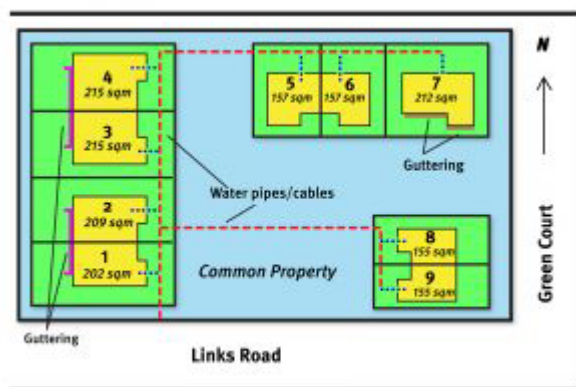
The proposed development is for a Reconfiguring a Lot – 1 Lot into 2 Standard Format Lots and Common Property in the Low Density Residential Zone of the Mareeba Shire Council's Planning Scheme. The site is located at 1 Matilda Close and 27 Summer Street, Mareeba and is more particularly described as Lot 74 on SP325396. The site is generally regular in shape, has an area of 1,032 m² and encompasses two (2) existing Dwelling Units.

A Development Permit is sought to subdivide Lot 74 on SP325396 creating an additional Low Density Residential Allotment within the existing Mareeba Residential Area in the form of Standard Format Plan Allotments. No change to the existing Residential nature or character of the Zone is envisaged with the Reconfiguration. The proposal will provide for an additional Residential Allotment while maintaining the existing amenities and aesthetics of the site.

The proponent has informed Freshwater Planning Pty Ltd that the purpose of the type of Subdivision is due to the location of the existing services to the property. Twine Surveys Pty Ltd have provided Freshwater Planning Pty Ltd with the following in relation to the provision of servicing in relation to Standard Format Plans. 'The Queensland Government's Utility Infrastructure Maintenance provide for the following:

This diagram gives an example of utility infrastructure responsibilities in a standard format plan.

The body corporate is responsible for the:

- Water pipes or cables shown as dashed lines (red) as they supply the service to more than 1 lot.
- Guttering and associated downpipes shown with the solid (pink) spanning 2 lots (1 and 2 and 3 and 4) supplying a service to more than 1 lot.
- Any television antenna that services 2 or more lots.

The lot owner is responsible for the:

- Water pipes or cables shown as dotted lines (blue) as they are located within the lot boundary and service 1 lot only.
- Guttering and associated downpipes shown as solid shading above lot 7 (brown).

The Reconfiguring a Lot proposes two (2) Residential Standard Format Allotments described as proposed Lots 1 and 27 and Common Property. The proposed areas of the allotments are:

Proposed Lot 1	510 m ²
Proposed Lot 27	521 m ²
Common Property	1 m ² .

The site gains access from the existing Road Network, being Matilda Close and Summer Street, via existing crossovers with no change to the existing proposed. The site is connected to all available services with the proposed two (2) Residential Standard Format Allotments not changing any of the existing servicing arrangements or improvements.

It is not considered that the proposed Reconfiguration will be detrimental to the adjacent sites or adversely impact on the surrounding area. It is considered that the Performance Outcomes of the both the Low Density Residential Zone Code and the Reconfiguring a Lot Code can be met in this instance.

The proposed Reconfiguration is located in the Low Density Residential Zone of the Mareeba Shire Council's Planning Scheme. Reconfiguring a Lot is a Code Assessable Use within this Zone. The application is Code Assessable.

Far North Queensland Regional Plan 2009-2031

Lot 74 on SP325396 is identified as being in the Urban Footprint designation of the FNQ Regional Plan Mapping.

The proposal is considered to be a re-subdivision (infill/re-development) of an existing site, the Reconfiguration is within the Urban Footprint and results in the creation of greater densities without affecting the existing natural environment.

It is considered that the proposed Reconfiguration is not in conflict with the Intent for Urban Footprint designation in the FNQ Regional Plan 2009-2031.

Low Density Residential Zone Code

A Development Permit for a Reconfiguring a Lot – 1 Lot into 2 Standard Format Lots and Common Property is sought to provide an additional Residential Allotment within the Mareeba Residential Area. The site is designated within the Low Density Residential Zone and no change to the existing Residential Zone is proposed with the Reconfiguration. The proposal will maintain the existing amenities of the site and compliment the surrounding and adjoining Residential Areas.

The site contains two (2) existing Dwelling Units which are provided with appropriate setbacks and fencing. No change to the existing Units is envisaged with the proposal ensuring that each Unit is provided on an individual Standard Format Allotment. No change to the existing Residential nature or character of the Zone is envisaged with the Reconfiguration nor is any change to the existing Residential Uses of the site. The site is surrounded by Low Density Residential Allotments with no change to the existing is envisaged. The proposal is considered to comply with the purpose of the Low Density Residential Zone as the provision of Residential Allotments will ensure that the existing Residential Uses will be provided over the site now and within the future.

It is not considered that the proposal is in conflict with the relevant aspects of the Low Density Residential Zone Code. The proposal offers similar character and nature to what is existing whilst enhancing the existing character. The proposed Reconfiguration is considered acceptable and appropriate.

Airports Environs Overlay Code

The site is located outside of the 3km and within the 8km Bird and Bat Zone of the Bird and Bat Strike Zones and outside the Light Intensity – Mareeba Overlay Mapping. The proposed Reconfiguration is not considered to adversely affect the site, immediate vicinity or surrounds. The proposal is not for a waste disposal site. It is considered that the Airports Environs Overlay Code is Not Applicable to the proposed Residential Subdivision given the site being located outside the Light Intensity Zone and within the 8km for Bird and Bat Strike Zones.

Bushfire Hazard Overlay Code

The site is Mapped as containing Medium Bushfire Hazard on the Bushfire Hazard Overlay Mapping. The proposal is for the Reconfiguration to subdivide 74 on SP325396 creating an additional Residential Allotment within the Low Density Residential Zone of Mareeba.

The site is clear of any vegetation and is bounded by Matilda Close and Summer Street and other Residential Allotments ensuring appropriate firebreaks and setbacks to any Hazard Vegetation. The proponents will ensure that maintenance and upkeep of the site will be maintained to ensure no build-up of hazardous materials, and that existing or proposed firebreaks are maintained. It is not considered that the proposal will affect the Bushfire Hazard of the site as the site will ensure to remove any piling of fuel loads, contains existing firebreaks, and is provided with appropriate water sources. The site is connected to Council's Reticulated Water Supply which is understood to contain sufficient storage of water for Firefighting Supply. As the proposed Residential Allotments do not contain Vegetation nor any considered appropriate Bushfire Hazard Mapping, the Bushfire Hazard Overlay is not considered applicable in this instance.

Environment Significance Overlay Code

The site is Mapped as containing a Waterway Buffer on the Environment Significance Map. No new buildings or structures are proposed with the Reconfiguration as the site contains existing Dwelling Units. Therefore, no additional stormwater drainage or wastewater drainage will be discharged into the Mapped Waterway with the Reconfiguration. It is considered that the proposed development is not in conflict with the purpose of the Environment Significance Overlay Code and is acceptable.

Reconfiguring a Lot Code

The proposal is for a Reconfiguring a Lot – 1 Lot into 2 Standard Format Lots in the Low Density Residential Zone of the Mareeba Shire Council's Planning Scheme. The proposal is sought to create an additional Residential Allotment within the Mareeba Residential Area. The proposal will ensure that each allotment appropriately contains an existing Dwelling Unit with no change to the existing buildings, structures or Uses envisaged with the Subdivision. No change to the existing Residential nature or character of the Zone is envisaged with the Reconfiguration. The proposed Reconfiguration is to preserve the existing nature of the site and the immediate and surrounding amenity in accordance with the Mareeba Shire Council's Planning Scheme.

The minimum lot size in the Low Density Residential Zone's is 600 m² requiring a minimum frontage of 16 metres. Existing Lot 74 on SP325396 has an area of 1,032 m² and frontages to both Matilda Close and Summer Street. The proposed Lots and areas are as follows:

<u>Proposed Allotments</u>	<u>Area (m²)</u>	<u>Frontage (m)</u>
Proposed Lot 1	510 m ²	16.16 m
Proposed Lot 2	521 m ²	42.78 m
Common Property	1.0 m ²	0.50 m.

Each proposed allotment contains areas sufficient to encompass the existing Dwelling Units and be provided with appropriate setbacks and liveability. No change to the existing accesses is envisaged with the Reconfiguration and it is accepted that each allotment contains the safe provision of access to the existing Road Network. No new buildings or structures are proposed with this application and each proposed allotment provided with all available services of reticulated power, telecommunications, water and sewerage.

Whilst the proposed allotments do not meet the minimum area requirements of the Mareeba Shire Council's Planning Scheme Reconfiguring a Lot Code, the proposal provides for sufficient area for the provision of the existing Dwelling Unit, private open space (liveability), and appropriate setbacks. This includes the provision of the existing covered parking space for each Unit. The proposal is considered to formalise the existing

arrangement via the provision of Standard Format Allotments. It is not considered that the proposed Reconfiguration will be detrimental to the adjacent sites or adversely impact on the surrounding area. It is considered that the Performance Outcomes of the Reconfiguring a Lot Code can be met in this instance.

Works, Services, and Infrastructure Code

The proposal is for a Reconfiguration of 1 Lot into 2 Standard Format Lots in the Low Density Residential Zone of the Mareeba Shire Council's Planning Scheme. The proposal provides each allotment with the existing connection to all available services (Urban Servicing) as per noted above. The Reconfiguration will be provided with an appropriate level of Stormwater disposal as per existing. The site gains access from the existing Road Network, being Matilda Close and Summer Street with no change to the existing envisaged with the proposal. The proposed Subdivision will ensure that no change to the existing Uses and Residential nature of the site and surrounding area is envisaged.

No Excavation or Filling is proposed with the Reconfiguration however, if any significant Excavation or Filling associated with the proposed Reconfiguration is required than any resultant earthworks will be provided as part of an Operational Works Application.

It is considered that the proposed Reconfiguration complies with the Intent of the Works, Services, and Infrastructure Code.

Conclusion

It is considered that the proposed development being a Reconfiguring a Lot – 1 Lot into 2 Standard Format Lots and Common Property over land described as Lot 74 on SP325396 is appropriate. In particular, the proposed development:

- ✚ Can meet the Performance Outcomes relating to minimum allotment size and dimension;
- ✚ No change to the existing Residential nature or character of the area is envisaged, and the Subdivision will ensure that the new allotments will remain to be used for Residential Uses;
- ✚ Can meet the Performance Outcomes, Purposes and the Intent of the Reconfiguring a Lot Code for land included in the Low Density Residential Zone;
- ✚ Can meet the Intent and Objectives for the Low Density Residential Zone;
- ✚ Is not in conflict with the Far North Queensland Regional Plan 2009 – 2031, in particular the Urban Footprint Designation;
- ✚ Allows for a Subdivision format accepting of the existing servicing location; and
- ✚ Provides an additional Residential Allotment within the Mareeba Township
