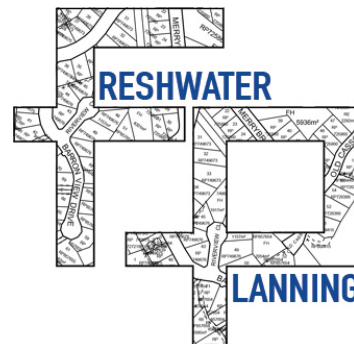

**RE: APPLICATION FOR RECONFIGURING A LOT – 1 LOT INTO 2 LOTS
LOT 27 ON DA150, 13 – 15 MAIN STREET, MOUNT MOLLOY.**

This application is for a Reconfiguring a Lot – 1 Lot into 2 Lots over land described as Lot 27 on DA150, situated at 13 – 15 Main Street, Mount Molloy is submitted on behalf of RUTHERGLEN DEVELOPMENT CO PTY LTD.

The application comprises of Application Form, SmartMap, Sketch Plan and this Town Planning Submission.

The Site

The subject land is described as Lot 27 on DA150, Locality of Mareeba and situated at 13 – 15 Main Street, Mount Molloy. The site is owned by RUTHERGLEN DEVELOPMENT CO PTY LTD who is also the applicant for the proposed development. The site is FreeHold, generally regular in shape, has an area of 2,792 m², contains frontage to Main and Crothers Streets and encompasses existing structures. The site is access from the existing Road Network and is provided with all available and necessary services.

In relation to the current State Governmental Mapping the site is Not Mapped as containing Remnant Vegetation, Regrowth Vegetation and Essential Habitat nor is the site designated as including a Referable Wetland or Wetland Protection Area. The site is located within 25 metres of a State Controlled Road, being Main Street. The site is not located within 25 metres of a Railway Corridor. It is understood that the proposal may require Referral to the Department for Transport and Main Roads Concerns.

The Proposed Development

The proposed development is for a Reconfiguring a Lot – 1 Lot into 2 Lots in the Centre Zone of the Mareeba Shire Planning Scheme. The site is located at 13 – 15 Main Street, Mount Molloy and is more particularly described as Lot 27 on DA150. The site is generally regular in shape, has an area of 2,792 m² and contains existing Buildings and Structures. No change to the existing structures is proposed with the Reconfiguration. In relation to the existing Improvements over the site, the proposed new allotments will separate the existing buildings providing them with appropriate setbacks and ensuring that each existing Building is located on an individual allotment. The proposed Subdivision follows the existing Fenceline that separates the existing Buildings.

A Development Permit for a Reconfiguration of 1 Lot into 2 Lots is sought to subdivide Lot 27 on DA150 creating an additional Commercial Allotment. The site is designated within the Centre Zone of the Mareeba Shire Planning Scheme and no change to the Centre Zone is proposed with the Reconfiguration. The proposal will provide an additional Allotment while maintaining the existing amenities and aesthetics of the site.

The Reconfiguration of a Lot proposes two (2) Allotments described as proposed Lots 1 and 2. The proposed areas of the allotments are as follows:

Proposed Lot 1	1,730 m ²
Proposed Lot 2	1,062 m ² .

The site gains access from the existing Road Network, being Crothers Street with each proposed Allotment able to be provided with access from this existing Road Network, as per existing. The site is connected to all available and necessary services with the proposed Commercial Allotments able to be provided with the same level of servicing. The site contains separate Electricity Meters and Effluent Disposal Systems.

The proposed allotments meet the minimum area requirements of the Mareeba Shire Planning Scheme's Reconfiguring a Lot Code. It is not considered that the proposed Subdivision will be detrimental to the adjacent sites or adversely impact on the immediate and surrounding areas. It is considered that the Purposes and Performance Outcomes of the Centre Zone and the Reconfiguring a Lot Code can be met in this instance.

The site is located in the Centre Zone of the Mareeba Shire Planning Scheme. The proposed Reconfiguring a Lot is a Code Assessable Use within this Zone. The application is Code Assessable.

Far North Queensland Regional Plan 2009-2031

Lot 27 on DA150 is identified as being in the Urban Footprint designation of the FNQ Regional Plan Mapping.

The proposal is considered to be a re-subdivision (infill/re-development) of an existing site. The Reconfiguration is within the Urban Footprint and results in the creation of greater densities without affecting the existing natural environment. The proposal is appropriate and acceptable while providing additional opportunities for within the Mount Molloy Township and the Mareeba Shire.

It is considered that the proposed Reconfiguration is not in conflict with the Intent for Urban Footprint designation of the FNQ Regional Plan 2009-2031.

Centre Zone

The proposal is for a Reconfiguration of 1 Lot into 2 Lots in the Centre Zone of the Mareeba Shire Planning Scheme. The purpose of the Reconfiguration is to provide an additional Commercial Allotment within the Mount Molloy CBD Area. The site is designated within the Centre Zone and no change to the existing and Commercial Uses and Centre Zone is proposed with the Reconfiguration. The proposal will maintain the existing amenities of the site and compliment the surrounding and adjoining Commercial, Industrial and Residential Areas.

The site contains two existing Buildings with the proposed Reconfiguration following the existing Fenceline. No new buildings are proposed and each proposed allotment will contain an existing Building with existing setbacks. The site is surrounded by a mixture of Uses including Low Density Residential, Industrial and Commercial Allotments with no change to the existing is envisaged. The proposal is considered to comply with the purpose of the Centre Zone as the provision of Commercial Allotments will ensure that the existing Uses will be provided over the site now and within the future.

The site contains an existing Buildings and Structures with no change to the existing improvements proposed with the Reconfiguration. The proposal provides for acceptable and appropriate setbacks with no new buildings or structures proposed. The proposed allotments are considered to provide appropriate areas and dimensions for the retention of an existing Building on each allotment. No change to the existing character, amenity and nature of the site and existing is envisaged with the Reconfiguration.

It is not considered that the proposal is in conflict with the relevant aspects of the Centre Zone Code. The proposal offers similar character and nature to what is existing whilst enhancing the existing character. The proposed Reconfiguration is considered acceptable and appropriate.

Flood Hazard Overlay Code

The site is located within the Queensland Floodplain Assessment Overlay as demonstrated on the Flood Hazard Overlay Mapping. However, it is noted that the whole of Mount Molloy's Township Area is Mapped within the Overlay. The proposal is for the Subdivision of the site separating the existing Buildings onsite, no change to the existing Flood Immunity is proposed with the proposed Reconfiguration. It is considered that the proposed Subdivision is Not Applicable to the Flood Hazard Overlay Code.

Reconfiguring a Lot Code

The proposal is for a Reconfiguring a Lot – 1 Lot into 2 Lots in the Centre Zone of the Mareeba Shire Council's Planning Scheme. The proposal is sought to create an additional Urban Allotment within the Mount Molloy Township Area while separating the existing Buildings onsite. The proposed Subdivision follows the existing Fenceline of the property. The proposal also provides greater densities than existing, further consolidating the Urban Area. No change to the existing Commercial nature or character of the Zone is envisaged with the Reconfiguration. The proposed Reconfiguration is to preserve the existing nature of the site and the immediate and surrounding amenity in accordance with the Mareeba Shire Planning Scheme.

The minimum lot size in the Centre Zone's is 800 m² requiring a minimum frontage of 20 metres. Existing Lot 27 on DA150 has an area of 2,792 m². The Reconfiguration of a Lot proposes two (2) Urban Allotments described as proposed Lots 1 and 2. The proposed areas and frontages of the allotments are:

<u>Proposed Allotments</u>	<u>Area (m²)</u>	<u>Frontage (m)</u>
Proposed Lot 1	1,730 m ²	81.50 metres
Proposed Lot 2	1,062 m ²	27.00 metres

Each proposed allotment contains areas greater than the minimum requirements within the Code. Additionally, each proposed allotment contains a frontage to the existing Road Network greater than 27.0 metres. The site is connected to all available and necessary services with no change to the existing services is proposed with the Reconfiguration. The proposed Subdivision will ensure that no change to the existing Centre/Commercial/Urban nature of the site and surrounding area is envisaged. The proposal will provide for an additional Urban Allotment while maintaining the existing amenities and aesthetics of the site.

The site gains access from the existing Road Network, being Crothers Street, via existing crossovers. No change to the existing is proposed. The proposal ensures the safe provision of access is provided to each allotment from the existing Road Network.

The proposed allotments meet the minimum area requirements of the Mareeba Shire Planning Scheme Reconfiguring a Lot Code. It is not considered that the proposed Reconfiguration will be detrimental to the adjacent sites or adversely impact on the surrounding area. It is considered that the Performance Outcomes of the Reconfiguring a Lot Code can be met in this instance.

Works, Services, and Infrastructure Code

The proposal is for a Reconfiguration of 1 Lot into 2 Lots in the Centre Zone. Each proposed allotment can be connected to all available and necessary services being Reticulated Electricity, Telecommunications and Water and will be provided with an appropriate level of Stormwater disposal and an effective Effluent Disposal System. The site contains separate Electricity Meters and Effluent Disposal Systems. The proposed Subdivision will ensure that no change to the existing Uses and nature of the site and surrounding area is envisaged.

No Excavation or Filling is proposed with the Reconfiguration other than site preparation however, if any significant Excavation or Filling associated with the proposed Reconfiguration is required than any resultant earthworks will be provided as part of an Operational Works Application.

It is considered that the proposed Reconfiguration complies with the Intent of the Works, Services and Infrastructure Code.

Conclusion

It is considered that the proposed development being a Reconfiguration of a Lot into two (2) Urban/Centre Allotments over land described as Lot 27 on DA150 is appropriate. In particular, the proposed development:

- ✚ Can meet the Acceptable Outcomes and Performance Outcomes relating to minimum allotment size and dimension;
- ✚ No change to the existing Urban/Centre/Commercial nature or character of the area is envisaged, and the Subdivision will ensure that the new allotments will remain to be used as existing or for Urban Uses within the Centre Zone;
- ✚ Can meet the Performance Outcomes and the Intent of the Reconfiguring a Lot Code for land included in the Centre Zone;
- ✚ Can meet the Intent and Objectives and Intent for the Centre Zone;
- ✚ Is not in conflict with the Far North Queensland Regional Plan 2009 – 2031, in particular the Urban Footprint Designation; and
- ✚ Provides an additional Urban Allotment within the Mount Molloy CBD and Township.

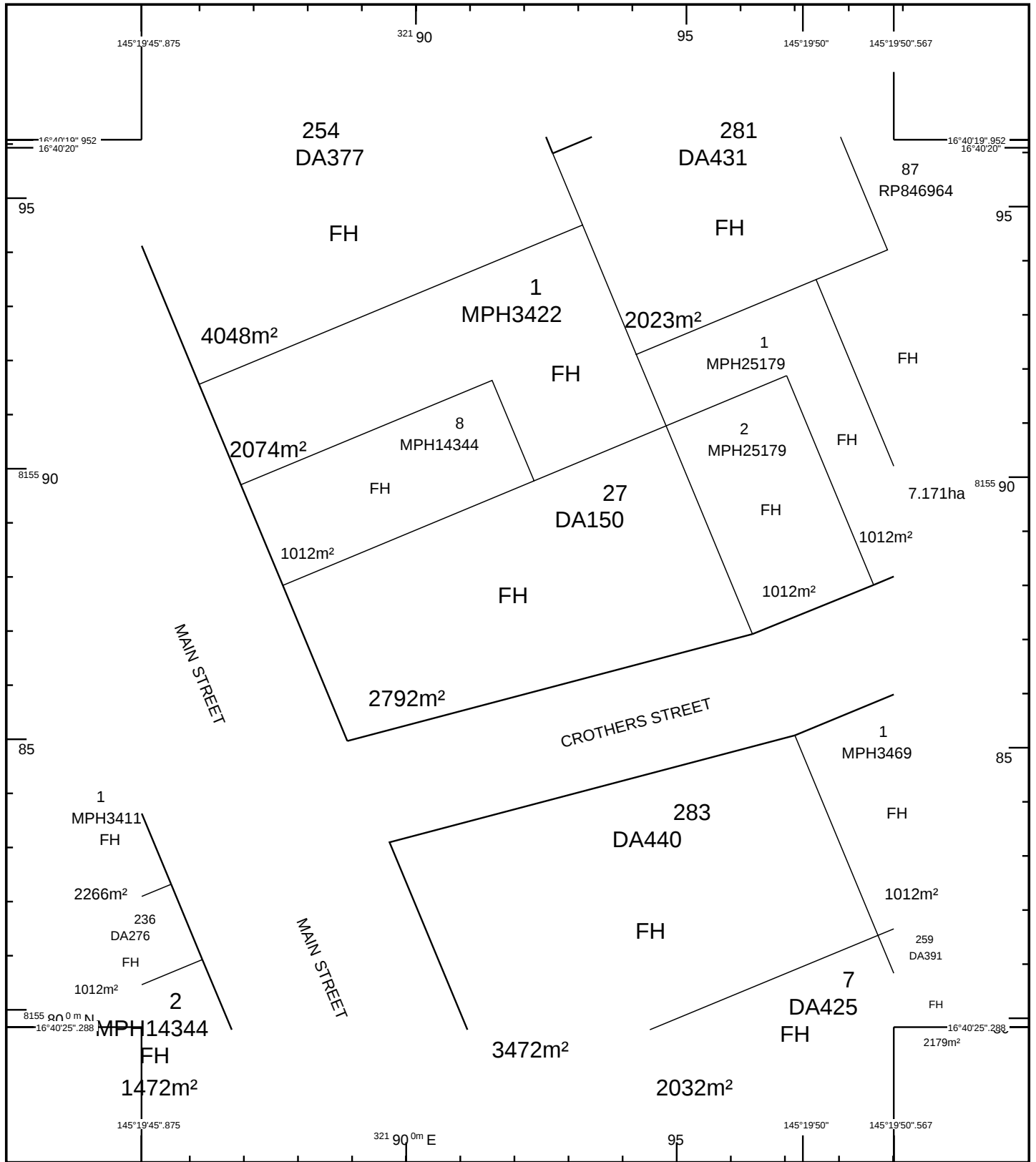

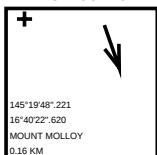
