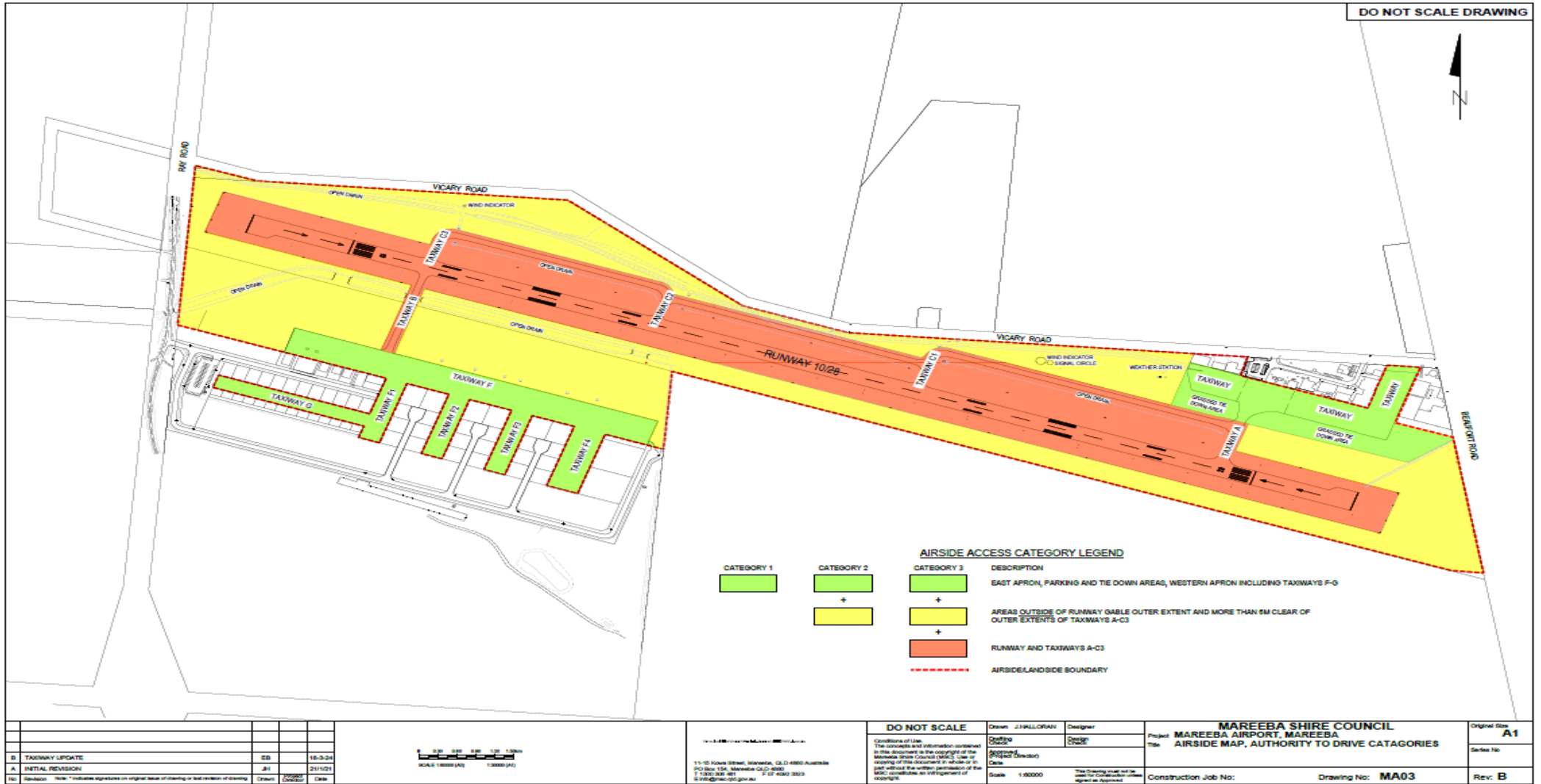

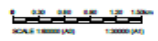
Mareeba Aerodrome Information Sheet - Vehicle Airside Application (VAA)
<p><b>Issue of VAA Permits</b></p> <p>A VAA is an authority to drive airside on the Mareeba Aerodrome and permits are issued by Mareeba Shire Council. The permit holder is permitted to operate a vehicle within certain designated areas of the aerodrome, depending on the category of the VAA.</p> <p>Permits must be always displayed in a prominent position, for viewing by the ARO or delegation Council Officer.</p>
<p><b>Applying for a VAA</b></p> <p>An applicant must demonstrate a valid and reasonable need for a VAA and should not assume there is a right to drive airside. The applicant must demonstrate that there is an operational requirement for frequent unescorted access to the airside before Mareeba Shire Council will issue a VAA to a person.</p> <p><b>Application must be submitted no less than seven business days before any anticipated need for the VAA.</b></p>
<p><b>Termination of Authority</b></p> <p>Mareeba Shire Council or delegate may withdraw a VAA, should an infringement of the Mareeba Aerodrome Standard Conditions be observed or reported:</p> <ol style="list-style-type: none"> <li>Depending on the infringement a verbal warning maybe issued by the ARO or Mareeba Shire Council Management for any infringement of the Mareeba Aerodrome Standard Conditions.</li> <li>Repeated infringements will result in Mareeba Shire Council issuing a written warning.</li> <li>Should the same infringement occur following a written warning, suspension of the individual's VAA. The period of suspension will be 14 calendar days.</li> <li>Should the same infringement be repeated after the 14-day suspension, a 12-month suspension or permanent cancellation of the VAA will be enforced.</li> <li>Where a particular infringement is repeated within a period in excess of 12 months, a 14 day suspension will be incurred; and</li> <li>Depending on the severity of the infringement or infringement history, Mareeba Shire Council will have the option to immediately suspend or cancel the VAA.</li> </ol>
<p><b>Driving airside without a VAA in place or when a VAA has been suspended or cancelled, may result in penalties in accordance with the relevant Local Law.</b></p> <p><b>Mareeba Shire Council reserves the right to terminate this permit at its Sole Discretion.</b></p>
