In submitting this airside access card application, I acknowledge that:

- 1. The airside access card and key remain the property of Mareeba Shire Council and has been allocated to me for my exclusive use. I will not permit another person to borrow or use the airside access card or key. I will advise Mareeba Shire Council immediately if the card or key is lost.
- 2. I will be using the airside access card and key when I have a valid work-related reason for airside access.
- 3. I will ensure that all access gates are closed securely behind me.
- 4. If I am required to use the vehicle access gates, I will comply with the requirements of the Mareeba Aerodrome Standard Conditions. I will not permit the entry of any other vehicle via an airside access gate.
- 5. Animals must not be taken airside unless contained within an approved animal cage/carrier.
- 6. High visibility clothing will be worn at all times when walking on aircraft movement areas.
- 7. Airside access cards and keys are not transferable between persons.
- 8. The airside access card and key mut be provided to Mareeba Shire Council on expiry, termination with employer or on request by Mareeba Shire Council.
- 9. I am responsible for advising Mareeba Shire Council of any change in personal details. My airside access approval and key may be cancelled if Mareeba Shire Council is unable to contact me.
- 10. The airside access card and key may be cancelled/suspended at any time by Mareeba Shire Council for breaching any of these Terms and Conditions.
