Mareeba Shire Council is requesting proposals from suitably experienced artists to repaint and extend an existing mural at Geraghty Park Hall, Julatten.

#### PART 5 - SCOPE

#### Site

Located at 34 Geraghty Park Road off the Mossman – Mt Molloy Road, Geraghty Park Hall is a community facility that is well used by local residents and is a popular rest stop for travellers. The larger facility is home to several community groups, including the Centre for Australasian Theatre, Julatten Edna Head Library and Craft Group and Julatten Mens Shed. The facility hosts regular weekend markets and creative performances and the main hall is available for hire by the general public.

The existing mural was painted by Diana Abiad (with assistance by Bob Ibbetson) in 1999. It depicts amateur journalist, Peter Justice who lived in Julatten during the 1980's and 90's and started producing a local Bulletin in 1987 which featured current affairs, local history articles and poetry. The existing mural was painted with a quality acrylic (no surface treatment) directly onto the concrete block wall and is faded but in reasonable condition for its age.

#### **Design Brief**

The existing mural should be re-painted as close to the original design and colours as possible. The original artist has provided permission for repainting of the existing mural to occur. The dimensions of the existing mural are: width 7.7m by height 2.6m (with two window spaces).

The mural may be extended to adjacent walls of the Hall. The location and dimensions of any new additions should be detailed in the artist's proposal. Content for new additions to the mural may reference:

- local birdlife;
- historical local logging and dairy industries;
- past and present uses of Geraghty Park and Hall (e.g. theatre and dance, library, woodwork and crafts, horse and other sports.)

Artists are responsible for any research or further consultation to inform the artwork design and content and are referred to Mareeba Shire Council's Library local history collection for this purpose.

The artist is responsible for any cleaning and surface preparation prior to repainting and for applying a clear coat or graffiti protection coat when the artwork is completed.

The artwork should be responsive to the site and create a distinctive sense of place for residents and visitors. It should promote Julatten's unique local character, culture, heritage or natural environment. The purpose of the artwork is to enhance the visual appeal of this public space to improve liveability of the Shire.

#### **Project Budget**

Council has allocated a total budget of \$13,000 for this project.

### PART 6 – Proposal Requirements

Artists should submit a written proposal that addresses the following specific items:

- Short written design statement and optional visual sketch designs.
- Demonstrated ability and experience creating original, quality artworks. Please include examples of previous work.
- Availability to complete the artwork within the indicative timeframes or proposed alternative timeframes.
- Itemised schedule of fees, that may include:
  - Consultation / research (optional, if required)
  - Design fees (including one scaled, sketch design and one revision)
  - Artist fees / labour (including cleaning, repainting of existing mural; please detail time frame to complete work)
  - Materials and equipment (high quality exterior grade acrylic and clear coat)
  - Travel and accommodation expenses (if required)
